It's hard to wrap our heads around how one Name can hold so much power, but that's exactly what the Church asks us to do in January, which is dedicated to *the **Holy Name of Jesus!***

Specific devotion to the name of **Jesus** began in 1274 when Pope Gregory X called the Universal Church to worship **Jesus'** Name. Dominicans preached on the devotion and built altars where Catholics could venerate the **Holy Name of Jesus.**

What does Scripture tell us?

*“Therefore, God has highly exalted him and bestowed on him the name that is above every name.”* Philippians 2:9

*“Whatever you ask in my name, this I will do, that the Father may be glorified in the Son.”*  
John 14:13

*“At **the name of Jesus**, every knee will bow in heaven, on earth, and under the earth.”*  
Philippians 2:10

*“For where two or three are gathered in my name, there am I among them.”*  
Matthew 18:20

Ways to Honor the **Holy Name of Jesus**

Repeat His Name lovingly: one of the simplest ways to honor **Jesus** is to utter “**I love you, Jesus**” or “**My Jesus**” throughout the day. You can even set reminders to help you develop a habit.

Make acts of Reparation: any time you hear **Jesus'** Name taken in vain or blasphemed, say, “Blessed be God. Blessed be His Holy Name.”

Meditate on His Holy Name: spend time contemplating the **Name of Jesus** and the power it holds. Let it fill you and bring you peace.

Pray the Litany of the **Most Holy Name of Jesus**: this litany honors and invokes Jesus through His many titles.

Obey the Second Commandment: God forbids us from taking His Name in vain, and doing so is a grave sin.

Let us all honor the **Holy Name of Jesus** so that He receives the homage He is due.






**Monthly Men's Group—Cor**

## ST. PAUL CENTER FOR BIBLICAL THEOLOGY

### Perfect Offering

Jesus speaks through the prophet Isaiah in today's First Reading. He tells us of the mission given to Him by the Father from the womb: "'You are My servant,' He said to Me, 'Servant and Son, our Lord was sent to lead a new exodus - to raise up the exiled tribes of Israel, to gather and restore them to God. More than that, He was to be a light to the nations, that God's salvation may reach to the ends of the earth (see Acts 13:46-47).

Before the first exodus, a lamb was offered in sacrifice and its blood painted on the Israelites' door posts. The blood of the lamb identified their homes and the Lord "passed over" these in executing judgment on the Egyptians (see Exodus 12:1-23,27).

In the new exodus, Jesus is the "Lamb of God," as John beholds Him in the Gospel today (see 1 Corinthians 5:7; 1 Peter 1:18-19). Our Lord sings of this in today's Psalm. He has come, He says, to offer His body to do the will of God (see Hebrews 10:3-13).

The sacrifices, oblations, holocausts, and sin-offerings given after the first exodus had no power to take away sins (see Hebrews 10:4). They were meant not to save but to teach (see Galatians 3:24). In offering these sacrifices, the people were to learn self-sacrifice - that they were made for worship, to offer themselves freely to God and to delight in His will.

Only Jesus could make that perfect offering of himself. And through His sacrifice, He has given us ears open to obedience, made it possible for us to hear the Father's call to holiness, as Paul says in today's Epistle. He has made us children of God, baptized in the blood of the Lamb (see Revelation 7:14). And we are to join our sacrifice to His, to offer our bodies - our lives - as living sacrifices in the spiritual worship of the Mass (see Romans 12:1).

(the "Diocese") entered an order [Docket No. 4471] (the "Nontestimonial Statement Order") granting the request of the Official Committee of Unsecured Creditors (the "Committee") for the presentation of nontestimonial statements (the "Statements") in the above captioned bankruptcy case (the "Bankruptcy Case").

Please take further notice that the hearings for the Statements (the "Statement Sessions") shall be held at the Robert H. Jackson U.S. Courthouse, 2 Niagara Square, Buffalo, New York on the following initial dates:

January 27, 2026 starting at 10:00 a.m. (Eastern)

January 28, 2026 starting at 10:00 a.m. (Eastern)

February 25, 2026 starting at 10:00 a.m. (Eastern)

February 26, 2026 starting at 10:00 a.m. (Eastern)

Please take further notice, that the Committee, in consultation with the Diocese, may seek to add additional Statement Session dates, if necessary, and subject to the Court's availability.

Please take further notice that the Statement Sessions will be subject to the following conditions:

Statements shall be made in person at the Robert H. Jackson U.S. Courthouse, 2 Niagara Square, Buffalo, New York. Persons who are unable to appear in person may request accommodations, including having counsel or another person read a written statement on their behalf, and the Bankruptcy Court will consider whether to grant any other accommodation.

Statements should not exceed twenty (20) minutes;

No parties in interest shall be expected or allowed to comment or respond to the Statements;

No statements or Statements of any party at the Statement Sessions will be considered as evidence in any matter or proceeding, including in the Bankruptcy Case, and no such statements or Statements will carry any evidentiary weight become part of the official record in the Bankruptcy Case.

The Statement Sessions will not be transcribed by a court reporter. The audio of the Statement Sessions will be recorded but any such recording shall be sealed and not available to the public or any party in any form except upon an order from the Court following a hearing upon notice to any affected persons or their counsel, counsel for the Diocese, and counsel for the Committee. To the extent the audio recording of a Statement or Statement Session is later released or transcribed pursuant to an order of this Court, such transcript or recording shall be sealed pending further Court order.

Persons who have Sexual Abuse Proofs of Claim in the Bankruptcy Case may elect to be identified only by their proof of claim number;

Consistent with Judicial Conference policy, no party or member of the public may photograph, video record, audio record, broadcast, televise, or otherwise transmit the Statement Sessions. Any media report concerning the statements made during the Statement Sessions shall not be considered evidence in any matter or proceeding in the Bankruptcy Case.

Please take further notice, any person impacted by the Bankruptcy Case who would like the opportunity to make a statement (a "Speaker") should contact, or, if represented by counsel, should have their counsel contact the Official Committee of Unsecured Creditors


