## From Fr. Cole Webster

It has been a very busy beginning of 2026! Our **Spiritual and Liturgical Pillars** have merged and have been busy planning for Lent. An Ad-Hoc Committee for the **Administration Pillar** has been working on a new website for the NEW St. Stanislaus and St. Katharine Drexel. The pillar is also obtaining renderings and estimates for new signage for all our campuses. Our **Faith Formation Pillar** has been teaching Bible Study, Faith Formation, and I am leading our book study on the Mass for adult formation. Our **Stewardship Pillar** continues to organize our fundraisers making sure there is no overlap, and our **In/Out Reach Pillar** assisted with our Advent Collection for the Mother Theresa Home.

Our **Finance Committees** have also met with the conclusion of the First Quarter (Sept-Nov). Gualbert has a \$395.80 surplus. Adalbert a surplus of \$6,278.04, St. John Kanty (rent minus utilities) has a surplus of \$55.91. St. Stanislaus is running a \$23,094.67 deficit. Leaders at our St. Stanislaus worship site are working with the diocese to reduce it's overhead. Currently, we are working with Buildings and Properties to sell 131 Townsend St, a vacant parish owned house next to the rectory garages.

As part of the in-depth look we are taking into St. Stanislaus, I wanted to share some interesting numbers for Sept. 2024-Aug. 2025.

**St. Katharine Drexel** concludes it's first quarter with a \$17,060.78 deficit. This is due to maintenance needed in the school building and an anticipated increase in payroll costs. While our previous secretary was on medical leave, her job duties were assigned to other staff as a temporary solution. With the organization of the Central Office, SKD is now once again paying for secretarial services. The former food pantry building has also sold for \$126,281.79.


## Monthly Men's Group—Cor

## ST. PAUL CENTER FOR BIBLICAL THEOLOGY

### History Redeemed

Today's Liturgy gives us a lesson in ancient Israelite geography and history.

Isaiah's prophecy in today's First Reading is quoted by Matthew in today's Gospel. Both intend to recall the apparent fall of the everlasting kingdom promised to David (see 2 Samuel 7:12-13; Psalm 89; Psalm 132:11-12).

Eight centuries before Christ, that part of the kingdom where the tribes of Zebulun and Naphtali lived was attacked by the Assyrians and the tribes were hauled off into captivity (see 2 Kings 15:29; 1 Chronicles 5:26).

It marked the beginning of the kingdom's end. It finally crumbled in the sixth century B.C., when Jerusalem was seized by Babylon and the remaining tribes were driven into exile (see 2 Kings 24:14).

Isaiah prophesied that Zebulun and Naphtali, the lands first to be degraded, would be the first to see the light of God's salvation. Jesus today fulfills that prophecy - announcing the restoration of David's kingdom at precisely the spot where the kingdom began to fall.

His gospel of the Kingdom includes not only the twelve tribes of Israel but all the nations - symbolized by the "Galilee of the Nations." Calling His first disciples, two fishermen on the Sea of Galilee, He appoints them to be "fishers of men" - gathering people from the ends of the earth.

They are to preach the gospel, Paul says in today's Epistle, to unite all peoples in the same mind and in the same purpose - in a worldwide kingdom of God.

By their preaching, Isaiah's promise has been delivered. A world in darkness has seen the light. The yoke of slavery and sin, borne by humanity since time began, has been smashed.

And we are able now, as we sing in today's Psalm, to dwell in the house of the Lord, to worship Him in the land of the living.

(the "Diocese") entered an order [Docket No. 4471] (the "Nontestimonial Statement Order") granting the request of the Official Committee of Unsecured Creditors (the "Committee") for the presentation of nontestimonial statements (the "Statements") in the above captioned bankruptcy case (the "Bankruptcy Case").

Please take further notice that the hearings for the Statements (the "Statement Sessions") shall be held at the Robert H. Jackson U.S. Courthouse, 2 Niagara Square, Buffalo, New York on the following initial dates:

January 27, 2026 starting at 10:00 a.m. (Eastern)

January 28, 2026 starting at 10:00 a.m. (Eastern)

February 25, 2026 starting at 10:00 a.m. (Eastern)

February 26, 2026 starting at 10:00 a.m. (Eastern)

Please take further notice, that the Committee, in consultation with the Diocese, may seek to add additional Statement Session dates, if necessary, and subject to the Court's availability.

Please take further notice that the Statement Sessions will be subject to the following conditions:

Statements shall be made in person at the Robert H. Jackson U.S. Courthouse, 2 Niagara Square, Buffalo, New York. Persons who are unable to appear in person may request accommodations, including having counsel or another person read a written statement on their behalf, and the Bankruptcy Court will consider whether to grant any other accommodation.

Statements should not exceed twenty (20) minutes;

No parties in interest shall be expected or allowed to comment or respond to the Statements;

No statements or Statements of any party at the Statement Sessions will be considered as evidence in any matter or proceeding, including in the Bankruptcy Case, and no such statements or Statements will carry any evidentiary weight become part of the official record in the Bankruptcy Case.

The Statement Sessions will not be transcribed by a court reporter. The audio of the Statement Sessions will be recorded but any such recording shall be sealed and not available to the public or any party in any form except upon an order from the Court following a hearing upon notice to any affected persons or their counsel, counsel for the Diocese, and counsel for the Committee. To the extent the audio recording of a Statement or Statement Session is later released or transcribed pursuant to an order of this Court, such transcript or recording shall be sealed pending further Court order.

Persons who have Sexual Abuse Proofs of Claim in the Bankruptcy Case may elect to be identified only by their proof of claim number;

Consistent with Judicial Conference policy, no party or member of the public may photograph, video record, audio record, broadcast, televise, or otherwise transmit the Statement Sessions. Any media report concerning the statements made during the Statement Sessions shall not be considered evidence in any matter or proceeding in the Bankruptcy Case.

Please take further notice, any person impacted by the Bankruptcy Case who would like the opportunity to make a statement (a "Speaker") should contact, or, if represented by counsel, should have their counsel contact the Official Committee of Unsecured Creditors
